- National Member Database Casey
 - Will be collecting data for entry over the next couple of months
 - Data helps with the securing of funding and grant money
- Pantry Hamilton County Pantry Collective Meeting May 19 Barb
 - o These meetings are part of Free Store/Food Bank
 - Was good discussion
 - Directive from USDA they can inspect pantries at any time
 - Can conduct audits
 - Free Store procedures for purchasing are being revised
 - Does Free Store have a resource list? SVdP does have one and it is available here
 - Free Store does list of food pantries and kitchens
 - Free Store All Agency meeting will be in August
- Hunger Walk if we participate can use our Account number 294 to have funds directed to us
- OHIO law, if passed, may restrict food distribution to smaller pantries if you see anything about, contact you state representative
- If Federally funded, cannot refuse people food emergency bags are OK
- One way to validate eligibility is to send post card to person lacking ID consensus was we should not pursue this as a means of validation
- Tour of Corpus Christi pantry serves three different parishes large and well organized; tracks inventory as people shop
- SVdP Presidents Meeting:
 - Attended meeting and raised question of Virtus training Steve stated we need to follow the diocesan guidelines
 - If Virtus trained, do not fall behind in continuing education diocese will revoke clearance
- Fan and AC Program at Bank Street Barb
- Pantry staffing need sub for June 17 Barb
- SVdP All Conference Meeting at St Savior June 29 Barb

Review and discuss what was purchased over the past month

- OHIO bonus allows for some food at no cost
- Steering away from items in glass containers due to breakage
- Thursday pick up and set up is very physical work Gail will see if her son can assist with unloading
- One constraint is the lack of space for storing items
- Another constraint is van drivers are limited to St B employees
- Reviewed questions and concerns
 - Will need to limit some items due lack of stock at the Free Store
 - Produce what to order? It comes in large lots and sometimes quality is poor

- Hard to gauge what is needed and how much to distribute
- Will limit the amount of milk ongoing due to availability and the weight
- Personal care items are running low how to handle Barb will put an item in the bulletin
- Is there a way to manage personal care items so they can be distributed to those most in need? If the shoppers ask
- Do we continue to purchase laundry detergent and dish detergent? Provide this soap since these items cannot be purchased with food stamps
- Continue to order TP from TNT since it is cheaper
- Continue to order soup thru the summer easy lunch for kids during the summer
- Bread and pastries will remain status quo for now
- Buying diapers at grocery store rather than Free Store need to continue to do this
- Continue to buy cherries and blueberries? Yes and place it with the fruit
- Will post the summer schedule will need to reset the pantry as noted

Fan and AC program is up and running

- If there is a request for fan or AC, need to send info to Bank Street and they will verify eligibility
- Distribution is at Bank Street

All Conference Meeting late June

Continue financial cap at \$250.00? Yes, continue with current cap

CAIN – Steve Crowe wants to visit their facility to see what they do

- Steve already contacted CAIN
- Barb anticipates a problem
- St B members sit on the CAIN board

Checkbook signers

- Only Vincentian has check signing authority
- SVDP money is a separate account
